In accordance with these principles, Accruit invests exchange funds with the primary investment objectives being ***liquidity*** and ***preservation of principal***. The Uniform Prudent Investor Act codifies the requirement for diversification of investments, and Accruit always exercises reasonable care, skill and caution when selecting investments. Accruit invests all exchange funds in bank depository products, U.S. Treasury Securities or equivalent products.

Accruit's investor standards are designed to assure that:

1. Client exchange funds are never commingled with Accruit's operating accounts.
2. Client funds are never loaned or transferred to any account not directly related to the client's 1031 exchange.
3. Exchange funds are always invested so as to provide 100% liquidity, assuring that Accruit can fulfill all contractual obligations to its clients and preserve the principal of the exchange funds.
